Philadelphia Nursing Home Panel Review



Purpose of the Panel

The purpose of the Nursing Home Review Panel is to review each Philadelphia **Pennhurst** or **Embreeville** class member who may need a skilled nursing or rehabilitation facility. The Nursing Home Review Panel must be informed of admission to a nursing home or rehabilitation facility in order to monitor progress to ensure quality and discharge.

Panel Membership

The panel is made up of a nurse, doctor, advocate and a representative from the Office of Developmental Programs (ODP).

Follow-Up Guidelines

The Nursing Home Panel will have a follow up meeting every **180 days** for any class member that continues to be in a nursing home or rehabilitation facility. It is suggested that those attending the meeting arrive **15 minutes prior** to your scheduled time. The county support coordinator is required to attend the meeting. All other team members are welcomed to attend as well.

Information Required

The information required to conduct the review the must be submitted to the Nursing Home Review Panel is as follows:

- Lifetime Medical History with all health diagnosis and treatments required over the past three months
- Nursing Home Review Panel Hospital Admission Follow-Up Form
- Current prognosis regarding health problems and medication review
- Proposed Nursing Home Discharge Plan
- Description of any possible environmental or staffing issues that need to be resolved to ensure a safe return to a community home
- Identification of any necessary skilled nursing needs

The *Nursing Home Review Panel Hospital Admission Information Form* is to be used anytime a Philadelphia **Pennhurst** or **Embreeville** class member is admitted to a hospital. The Hospital Admission Follow Up Form needs to be resubmitted anytime there is a change in the placement of a class member who has been hospitalized. The form should be submitted to the Nursing Home Review Panel Facilitator, **Jack Toomey, RN -BC, NADD-CC ,CDDN** at Philadelphia Coordinated Health Care (PCHC). The form should be sent using one of the following methods:
